Reproduction Order Form

The Alumni Association will provide duplication of images in its collections within the following guidelines:

1. All duplication will be done by the Akron-Summit County Public Library Special Collections staff or by contract with a commercial service chosen by the Association.
2. Due to the fragile nature of some materials, the Association reserves the right to refuse a request for reproduction that may jeopardize the safety of an item.
3. Reproduced images are to be used for personal or research purposes only. The purchaser agrees not to reproduce, publish, exhibit or sell copies of an image without obtaining written permission from the Alumni Association.
4. All reproductions must be credited to the Alumni Association of the Akron City Hospital School of Nursing. A suggested citation follows below:
 - Alumni Association of Akron City Hospital School of Nursing; ITEM TITLE, DATE.
5. The Copyright law of the United States (Title 17 United States Code) governs the making of photocopies or other reproductions of copyrighted material.

Under certain conditions specified by the law, libraries and archives are authorized to furnish a photocopy or other reproductions. One of these specified conditions is that the photocopy or reproduction is not to be “used for any purpose other than private study, scholarship, or research.” If a user makes a request for, or later uses, a photocopy or reproduction for purposes in excess of “fair use” that user may be liable for copyright infringement.

This institution reserves the right to refuse to accept a photocopy request, if in its judgment, fulfillment of the request would involve a violation of copyright law.
